Theory of Strategy

The Burmese military government and numerous ethnic minority armed groups have entered a series of ceasefires since 1989 in spite of the fact that most previous talks between 1949 and 1983 failed. Why did the parties enter into ceasefire accords? What is the nature of the accords? What have been the consequences? What are the future scenarios? Written by two Burmese researchers, this study investigates the underlying factors behind the ceasefires, explores the nature of the secretive agreements, and identifies the consequences affecting stakeholders in the larger context of peacebuilding, political settlement, democratization, and the state-building process. The study concludes that recent ceasefires present a significant first step in solving the sixty-year old civil war. However after more than 17 years, they have not brought about peace or political settlement. The government-initiated ceasefires carry a heavy military focus, primarily seeking to reduce military threats and gain better control over the borderlands while placing greater emphasis on state building than on peacebuilding. Nevertheless, the accords have allowed many ceasefire groups to maintain or increase their strength, develop their areas, and more importantly, ceasefires have resulted in the local ethnic population having relatively better lives. Many ethnic armed groups will continue to pursue their goals through political means, but if at least some of their objectives are not met, a resumption of violence cannot be ruled out.

This study examines the determinants and character of German policies toward the Soviet non-Russian nationalities and their effects on the Soviet and German war efforts and on the nationalities themselves. Particular emphasis is placed on the analysis of the nature and magnitude of military collaboration with the Germans by the non-Russian nationalities, in an attempt to examine the military exploitability of the political warfare opportunities that presented themselves. Section II outlines the attitudes toward the Soviet nationalities prevalent among the Nazi leadership and the role envisaged for them in a postwar German-dominated Europe, and juxtaposes them on the views of German officials who did not share Nazi dogma and advocated a more pragmatic approach. German policies in the occupied non-Russian territories and their implications are examined in Sec. III. Section IV describes the different types and degrees of military collaboration with the Germans. The main conclusions are summarized in Sec. V.

Freedom in the World

The Russo-Turkish War was one of the most decisive conflicts of the 18th century. In this book, Brian Davies offers a thorough survey of the war and explains why it was crucial to the political triumph of Catherine the Great, the southward expansion of the Russian Empire, and the rollback of Ottoman power from southeastern Europe. The war completed the incorporation of Ukraine into the Russian Empire, ended the independence of the great Cossack hosts, removed once and for all the military threat from the Crimean Khanate, began the partitions of Poland, and encouraged Catherine II to plan projects to complete the "liberation" of the lower Danubian and Balkan Slavs and Greeks. The war legitimated and secured the power of Catherine II, finally made the Pontic steppe safe for agricultural colonization, and won ports enabling Russia to control the Black Sea and become a leading grain exporter. Traditionally historians (Sorel, for example) have treated this war as the beginning of the "Eastern Question," the question of how the European powers should manage the decline of the Ottoman Empire. A thorough grasp of the Russo-Turkish War is essential to understanding the complexity and volatility of diplomacy in 18th-century Europe. This book will be an invaluable resource for all scholars and students on European military history and the history of Eastern Europe.

This book examines the ideas which have structured half a century of civil war in Burma, and the roles which political elites and foreign networks - from colonial missionaries to aid worker activists - have played in mediating understandings of ethnic conflict in the country. The book includes a brief overview of precolonial and colonial Burma, and the emergence ethnic identity as a politically salient characteristic. It describes the struggle for independence and the parliamentary era (1948-62), and the quarter century of military-socialist rule that followed (1962-88). The book analyses the causes,

dynamics and impacts of on-going armed conflict in Burma, since the 1988 'democracy uprising' through to the 2007 'saffron revolution' (when monks and ordinary people took to the streets in protest against the military regime). There is a special focus on the plight of displaced people, and the ways in which local and international agencies have responded. The book also examines one of the most significant, but least well-understood, political developments in Burma over the last twenty years: the series of ceasefires agreed since 1989 between the military government and most armed ethnic groups. The positive and negative impacts of the ceasefires are analysed, including a study of civil society among ethnic nationality communities. This analysis leads to a discussion of the nature of social and political change in Burma, and a re-examination of some commonly held assumptions regarding the country, including issues of ethnicity and federalism. The book concludes with a brief Epilogue, taking account of Cyclone Nargis, which struck Burma on 2 and 3 May 2008, resulting in a massive humanitarian crisis.

An Agenda for Peace

Small Wars

In the mid-1970s, the Cold War had frozen into a nuclear stalemate in Europe and retreated from the headlines in Asia. As Gerald Ford and Jimmy Carter fought for the presidency in late 1976, the superpower struggle overseas seemed to take a backseat to more contentious domestic issues of race relations and rising unemployment. There was one continent, however, where the Cold War was on the point of flaring hot: Africa. Jimmy Carter in Africa opens just after Henry Kissinger's failed 1975 plot in Angola, as Carter launches his presidential campaign. The Civil Rights Act was only a decade old, and issues of racial justice remained contentious. Racism at home undermined Americans' efforts to "win hearts and minds" abroad and provided potent propaganda to the Kremlin. As President Carter confronted Africa, the essence of American foreign policy--stopping Soviet expansion--slammed up against the most explosive and raw aspect of American domestic politics--racism. Drawing on candid interviews with Carter, as well as key U.S. and foreign diplomats, and on a dazzling array of international archival sources, Nancy Mitchell offers a timely reevaluation of the Carter administration and of the man himself. In the face of two major tests, in Rhodesia and the Horn of Africa, Carter grappled with questions of Cold War competition, domestic politics, personal loyalty, and decision-making style. Mitchell reveals an administration not beset by weakness and indecision, as is too commonly assumed, but rather constrained by Cold War dynamics and by the president's own temperament as he wrestled with a divided public and his own human failings. Jimmy Carter in Africa presents a stark portrait of how deeply Cold War politics and racial justice were intertwined.

What Women Do in Wartime

This study analyses the various types and stages of conflict that have been experienced by diverse groups and generations of Karen over the six decades of armed conflict between the Karen National Union (KNU) and successive Burmese governments. Instead of focusing on those who are internally displaced, those in the refugee camps on the Thai-Burma border or living abroad, or those in the KNU, it places particular emphasis on the "other" Karen, or the majority segment of the Karen population living inside Burma, a population that has hitherto received little scholarly and journalistic attention. It also assesses the Karen people's varied attitudes toward a number of political organizations that claim to represent their interests, toward successive Burmese military regimes, and toward the political issues that led to the original divide between "accommodators" and "rebels." This study argues that the lifestyles and strategies that the Karens have pursued are diverse and not confined to armed resistance. Acknowledging these multiple voices will not only shed light upon the many positive features of ethnic interactions, including harmonious communal relationships and significant attempts to promote peace and stability by encouraging "normal" activities and routines in both peaceful and war-torn areas; it will also help to identify policy recommendations for future ceasefire negotiations and a possible long-term political settlement within the context of a militarized Burma.

During the first quarter-century of the Cold War, upholding human rights was rarely a priority in U.S. policy toward Latin America. Seeking to protect U.S. national security, American policymakers quietly cultivated relations with politically ambitious Latin American militaries—a strategy clearly evident in the Ford administration's tacit support of state-sanctioned terror in Argentina following the 1976 military coup d'état. By the mid-1970s, however, the blossoming human rights

movement in the United States posed a serious threat to the maintenance of close U.S. ties to anticommunist, right-wing military regimes. The competition between cold warriors and human rights advocates culminated in a fierce struggle to define U.S. policy during the Jimmy Carter presidency. In *The Fate of Freedom Elsewhere*, William Michael Schmidli argues that Argentina emerged as the defining test case of Carter's promise to bring human rights to the center of his administration's foreign policy. Entering the Oval Office at the height of the kidnapping, torture, and murder of tens of thousands of Argentines by the military government, Carter set out to dramatically shift U.S. policy from subtle support to public condemnation of human rights violation. But could the administration elicit human rights improvements in the face of a zealous military dictatorship, rising Cold War tension, and domestic political opposition? By grappling with the disparate actors engaged in the struggle over human rights, including civil rights activists, second-wave feminists, chicano/a activists, religious progressives, members of the New Right, conservative cold warriors, and business leaders, Schmidli utilizes unique interviews with U.S. and Argentine actors as well as newly declassified archives to offer a telling analysis of the rise, efficacy, and limits of human rights in shaping U.S. foreign policy in the Cold War.
